- Perform an audit of UMBC's current international projects, activities and contracts



### BACKGROUND

"Higher education institutions are global enterprises. Like most industries in the 21st century, the higher education sector views "internationalization" as a fundamental business strategy. At one time, university "internationalization" meant successful study abroad programs, and to have such programs was something of a luxury. Today, study abroad is one facet of the university's global aspiration, which now includes foreign campuses; international degree programs; overseas scientific and medical research; cross-border consulting; student internships and work programs; regional alumni and fundraising centers; international student recruitment; partnerships with multinational corporations; service and experiential learning opportunities; distance education, and several variations of each of these, among other initiatives" (Ferreira, 2011)

Global operations is a term used to describe "management and business support for programs operating overseas as well as compliance with both U.S. and foreign regulations" (NACUBO, 2019). Topics include banking, contracts, corporate structure, export controls, human resources, legal presence, procurement, project management, registrations and licenses to conduct specific activities, risk management, taxation and travel logistics within an international context.

# Individual departments independently manage global operations functions with varying degrees of expertise and

Experts from across the institution/system make up an advisory team and variety of working groups to address global operations needs on a caseby-case basis.

## Centralized

A central administrative unit staffed by experts handles all global operations needs on behalf of the institutions.


Example: Arizona State University

Resources are managed at the system level to provide global operations support across campuses.

# UMBC EMPLOYEE TRAVEL, 2016 - 2018 Destinations Coded by State Department Travel Advisory Level



Level 1 - Exercise Normal Precautions: This is the lowest advisory level for safety and security risk.


Level 2 - Exercise Increased Caution: Be aware of heightened risks to safety and security.

Level 3 - Reconsider Travel: Avoid travel due to serious risks to safety and security.

Level 4 - Do Not Travel: This is the highest advisory level due to greater likelihood of life-threatening risks.

# DUTY OF CARE CONTINUUM




Fig. 2: Claus, L. (2011). Duty of Care and Travel Risk Management Global Benchmarking Study

## INITIAL RECOMMENDATIONS

- Develop Institutional Knowledge and Infrastructure to Support Global Operations
- Staff from Finance and Administration and IES should regularly attend NACUBO's Annual Global Operations Forum
  Global Operations Working Group should continue to convene on an ongoing basis
- Establish International Travel Policy and Dynamic Registry
- Goal is to be able to analyze risks, share resources to mitigate those risks and be able to assist in an emergency
- Advocate for USM Collective Involvement in Global Operations
- Address Current Policies and Procedures that inhibit global engagement.
   Example: Implement travel credit cards (specific to international travel) because many UMBC travelers are currently forced to carry thousands of dollars in cash for international travel

• Did you know that certain over-the-counter medicines in the U.S. are illegal in other countries?

- Develop a partnership with University of Maryland Baltimore (UMB) to utilize their travel clinic
   This would allow UMBC travelers to obtain required and recommended immunizations at a reduced rate as well as
